

Thus far, as we get closer to the House Bill Filling Deadline is later this week, we have already seen 4 anti-LGBTQ+ bils.



S442/H560 - Discriminates Against Trans Youth in Foster Care

S516 - Anti-trans Bathroom Bill

H595 & H636- Expansion of Don't Say Gay



Discriminates Against Trans Youth in Foster Care

BILL NUMBER IMPACT DATE FILLED

• Parents who raise their child based on their sex assigned at birth and are not supportive of their Trans/GNC child can not be subject to petition of abuse.

S442/H560

- Adoption and foster agencies may not deny the opportunity to become an adoptive/foster parent or remove the child based on unwillingness, or lack of support to enable the child to engage in gender transition.
- Raising a child consistent with the child's biological sex, including referring to a child consistent with the child's biological sex, and making related mental health or medical decisions based on the child's biological sex isn't child abuse. It doesn't constitute "serious mental injury."

Anti-trans Bathroom Bill

2025 Bill Tracker

BILL NUMBER IMPACT DATE FILLED

 Brings back HB2-style restrooms requirements in certain covered facilities

S516

 Bans the ability to change sex designations, also known as gender markers, in birth certificates and state-issued IDs

• Creates restrictive definitions for several terms, including "male", "female", "girl", "boy", "sex", etc.



Expansion of Don't Say Gay

BILL NUMBER IMPACT DATE FILLED

Major expansions on "Don't Say Gay" law S49

H595

• Will students' participation in "instructions" on gender identity, sexual activity, or sexuality, unless student is in grades 7-12 with written parental consent.


- Limits curriculum and changes to that curriculum when involving sexual health
- Book ban in public schools and public libraries, with the requirement for parental consent for minor access.

Attacks Access to Medication Abortion

2025 Bill Tracker

BILL NUMBER IMPACT DATE FILLED

H553

 Severely restricts medication abortion from entering the state by targeting clinics, suppliers, and manufactures

• There is simply no reason for the restriction on medication abortion, which is incredibly safe.

Attacks Minors Access to Healthcare

2025 Bill Tracker

BILL NUMBER IMPACT DATE FILLED

S759/H519

• Prevents young people from accessing treatment for STIs, contraception, and other safe, routine treatments necessary to ensure young people's well-being.

 Young people should be able to access care, information, and resources about their health and their bodies. They deserve confidential care and support from trusted adults – not barriers and delays. 03/25/2025
